

Privacy Policy

My Company (Linda Pitcher Fine Art) ("us", "we", "I" or "our") operates <http://www.lindapitcherfineart.co.uk> (the "Site"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information I receive from users of the Site.

Your privacy is something that I take very seriously. Any information you provide to me is held in strict confidence unless you give me permission to share it. I will not sell or rent your information to third parties for marketing or any other purposes. If you signup for my newsletter you are agreeing to receive updates and marketing emails from me only.

I use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

Information Collection or Use

While using our Site, I may ask you to provide me with certain personally identifiable information that can be used to contact or identify you and may be stored. Personally identifiable information may include, but is not limited to your name ("Personal Information"), Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information and purchase history. I may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. I also collect personally identifiable information (including name, email, password, communications); payment details (including credit card information), comments, feedback, product reviews, recommendations, and personal profile.

How do I Collect the Information

Information is collected when, for example, you send a message through a contact form, when you purchase a product in my store, or when you subscribe to my newsletter.

Log Data

Like many site operators, I collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

In addition, I use third party services such as Google Analytics that collect, monitor and analyse this.

My services are not designed for, or intentionally targeted at, children 13 years of age or younger. I do not intentionally collect or maintain data about anyone under the age of 13.

Why do I Collect such Personal Data

To provide and operate the Services and to be able to contact yourself with promotional newsletters/offers/promotional materials and other information. To create aggregated statistical data and other aggregated and/or inferred Nonpersonal Information, which I or Wix may use to provide and improve our respective services. To comply with any applicable laws and regulations.

How do I Store, Use, Share and Disclose your Personal Information

My company is hosted on the Wix.com platform. Wix.com provides me with the online platform that allows me to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com and used by my company adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

How do I Communicate with you

I may contact you to notify you regarding your account, to troubleshoot problems with your account, to resolve a dispute, to collect fees or monies owed, to poll your opinions through surveys or questionnaires, to send updates about my company, or as otherwise necessary to contact you to enforce any agreement we may have with you. For these purposes we may contact you via email, telephone, text messages, and postal mail.

Cookies

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, I use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

Security

I maintain security measures to protect your personal information from unauthorised access, misuse, or disclosure. However, no exchange of data over the Internet can be guaranteed as 100% secure. While I make every effort to protect your personal information shared with me through this Site, you acknowledge

that the personal information you voluntarily share through this Site could be accessed or tampered with by a third party.

You agree that I am not responsible for any intercepted information shared through this Site without my knowledge or permission. Additionally, you release me from any and all claims arising out of or related to the use of such intercepted information in any unauthorised manner.

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure.
